BIOGRAPHY:

Ron Terry, Ph.D., earned a B.A. in Geography in 1980 from the University of Hawai'i at Hilo. Supported by a National Science Foundation grant, he received a Ph.D. from Louisiana State University, also in Geography, in 1988. He was Assistant Professor of Geography at the University of Hawai'i at Hilo from 1987-1992. During his professorship he began his consulting business, and started full-time consulting in 1992. He remains an Affiliate Professor at UH-Hilo, and has been active in various boards and associations related to environmental science, including the Marine and Coastal Zone Management Advocacy Council (MACZAC), to which he was appointed by Governor Cayetano in 2000 and served till 2008, and the Mauna Kea Management Board, to which he was appointed in 2004 and on which he continues to serve. Terry also sits on the UH-Hilo Chancellor's Advisory Council.
